 - If you choose the 5 government meetings & 3 service hours, you cannot attend the same venue more than twice (including Reavis).
- You may only attend one meeting per evening.
- The calendar is not guaranteed. Often, meeting times are changed to accommodate holidays or other special occasions. **You should always call first to confirm the time and place.**
- You **MUST** arrive BEFORE the meeting starts to receive credit for attendance. Late arrivals will not be permitted to enter a meeting.
